Ms. Hicks went through the changes she made to the budget with a \$30,000 increase. She said the amount saved from the refinance on the debt service side was about \$46,000. Supervisor Behrens said she would like to use all the savings from the refinancing and put it into the operating budget to avoid an increase in the next couple of years. Ms. Hicks said she would recommend putting the additional funds into the reserve account. The Board agreed. Ms. Hicks said that a letter will have to go out to the community to let them know about the change to the assessments. Ms. Hicks also said she recommends having an additional page in the mailing to clarify that the debt service
